MEPs Intergroup fighting against poverty in defence of human rights reconfirmed as official European Parliament intergroup



As European Year for Development starts, the intergroup "Extreme Poverty and Human Rights" has once again been recognised as an official intergroup of the European Parliament for the 2014 - 2019 mandate. Intergroups are organised by MEPs from different political groups who wish to work together on specific themes in order to promote discussions, exchanges and reflection, both within the European institutions and with representatives of interest groups and civil society.

The intergroup fighting against poverty has existed since 1980 and was initiated by All Together in Dignity - ATD Fourth World. It will continue throughout this mandate to defend the interests of Europe's most deprived citizens, and to provide a structure for dialogue and consultation in order to enable Europe's most deprived to have a voice at European level.

The intergroup considers **poverty to be an attack on human dignity and on fundamental rights.** Inequality continues to rise in Europe and worldwide, as do the number of people living in poverty, or at risk of poverty its work remains of the utmost importance. By creating structures to enable dialogue and consultation, in order to redirect policies, each European - including those whose voices are so rarely heard in the European institutions - can find their place. The intergroup's objective is to introduce these concerns into the work of the European Parliament and to analyse legislative proposals with these concerns in mind. Alongside the organisation of events **amendments and written questions will be tabled to directly have an impact on European legislation**.

The intergroup bureau consists of Sylvie Goulard, ALDE, President, and Vice-Presidents Silvia Costa, S&D, Jean Lambert, Greens, Verónica Lope-Fontagné, EPP and welcomes MEPs wishing to fight against poverty and to defend fundamental rights who wish to join the intergroup. It will continue to work closely with All Together in Dignity, whose numerous EU branches provides support to the intergroup, as well as other NGOs and networks, such as EAPN, FEANSTA, the Social Platform...
